

OSKALOOSA CITY COUNCIL
REGULAR MEETING
August 1, 2022

The Oskaloosa City Council met in regular session on Monday, August 1, 2022 at 6:00 p.m. with Mayor Krutzfeldt presiding and the following members answering roll call: Almond, Burnett, Caligiuri, Comfort, Drost, Hermsen and Ossian. Absent: None.

Andy McGuire, Oskaloosa Arts Roundtable member, and Marion Gaughan, Library Director, gave a presentation on the city of Oskaloosa's "Iowa Great Place" designation from the Iowa Department of Cultural Affairs.

It was moved by Caligiuri, seconded by Almond to approve the consent agenda:
